### Trench Cave-In at Granby, CO Site


- ContractOne hired workers for a residential construction site in Granby, Colorado in June of 2018
- Rosario Martinez initially for drywall, carpentry work
- While Martinez was in a trench attaching copper piping to the main water line, the trench collapsed
- He was buried and the accident caused fatal injuries





### **OSHA** Investigation

- OSHA began investigation after the fatality was reported
- According to OSHA, ContractOne failed to train Martinez and other workers to identify or avoid trenching and excavation hazards.
- OSHA discovered the trench collapsed the day before and ContractOne did not incorporate additional safety measures
- Citation sought \$57k penalties





### **OSHA** Citation



- OSHA issues citations for serious violations of the construction excavation standards
- ContractOne was cited for a willful violation for failure to have an adequate protective system to protect employees from cave-in



- OSHA also cited ContractOne for serious violations of the general construction safety standards
- October 2018 OSHA NEP on Trenching, Excavation

## Reckless endangerment,

 Can be prosecuted under both OSH Act and state law

### OSHA and State Authority to Impose **Criminal Penalties**

- Section 17(e): criminal penalties for willful violations of an OSHA standard that result in death
- OSH Act does not preempt states from prosecuting under general criminal laws
  - manslaughter, criminally negligent homicide, criminal conspiracy, assault





### State Prosecution of Company Owner

- August 2019: Grand County, Co. prosecutors brought criminal charges against ContractOne company owner Bryan Johnson
- State criminal charges
  - One count: criminally negligent homicide (later dropped)
  - Two counts: reckless endangerment
  - One count: third degree assault
- June 2021: Johnson pled guilty to charges to reckless endangerment and third degree assault







### Criminal Sentencing







### OSHA Press Release on Johnson's Criminal Sentencing:

"Criminal enforcement is an effective enforcement tool. The timely prosecution of an individual within the community in which they work, and where the victim often resided, has a strong deterrent effect in the industry and sends a signal to the regulated community that certain behavior, such as that which results in significant harm to workers, will not be tolerated."

### What Employers Should Do



Train workers who are reassigned to trenching Train properly re trenching, excavation, retain training records Report fatality to OSHA within 8 hours

Be aware that **OSHA** inspectors may look for possible criminal violations and make criminal referrals following employee fatality

Preserve any available evidence
